**DONATION TOTAL:**

Federal income tax regulations require donors claiming deductions for charitable contributions consisting of property other than cash worth more than \$500 to file Internal Revenue Service Form 8283, 'Noncash Charitable Contribution'. Where the noncash charitable contribution, other than publicly traded securities, exceeds \$5,000 (including 'similar property' contributed to one or more charitable organizations), the donee charitable organizations must acknowledge the contribution on the Form 8282. In addition, donee charitable organizations are required to file Internal Revenue Service Form 8282, 'Donee Information Return'.
