- The Junior League of New Orleans assumes no liability in connection with the Shopping Card.
- We are not required to honor the Shopping Card discount on already reduced "sale" merchandise.
- Merchandise/food is to be discounted 20% for card holders unless an exclusion is noted on this contract.
