Participation Guidelines:

The Junior League of New Orleans is an organization of women whose mission is to advance women's leadership for meaningful community impact through volunteer action,

collaboration, and training.

- Participant space assignments will be determined by the Junior League of New Orleans based upon the best interests of the event and/or first-come, first-served basis. Space will be located inside the Pontchartrain Center.
- Participants must provide a minimum of one (1) adult representative during the event to supervise their station between the hours of 10:00 am to 4:00 pm on Saturday, October 28, 2023
- Participants can arrive as early as 6:00 am on the event day (October 28, 2023), and JLNO will provide additional details of specific arrival times as the event approaches. Participants must stay the entire length of the event and may not leave until the event's conclusion at 4:00 pm on October 28, and must vacate the premises by 5:00 pm, unless otherwise agreed to in advance.
- Participants grant permission to the Junior League of New Orleans to take photographs or record videos of participants and/or display during the event for the strict purpose of promotion and publicity of the event and/or the Junior League of New Orleans.
- Participants and their representatives shall conduct themselves in a manner that is appropriate for the family-oriented event, which includes but is not limited to the following restrictions: no smoking, no profanity, and no display of inappropriate content or clothing. In the event of inappropriate behavior at the event, the Junior League of New Orleans reserves the right to close the participant's booth, and all Sponsor fees paid to the Junior League of New Orleans will be forfeited.
- The nature of the Touch a Truck event involves the interaction of children with Participant's vehicle(s) so that the children are able to touch, see, and explore the participant's vehicle(s) and learn about the vehicle(s)'s function.
